The quorum at each such meeting shall for the time being be two, if there are only three Trustees or 50% of the total trustees. Decisions at meetings shall be taken by majority vote unless otherwise provided herein. The Chairman/President of the Trust shall preside at all the meetings. He will have the power of a casting vote in case of equal voting at any meeting on any matters. In his absence the Vice Chairman/ vice president will act as Chairman/ president.

Powers and duties of Managing Trustee/ Secretary:

The Managing Trustee/ Secretary shall be the convener and correspondent of the Trust, subject to the superintendence and general control of the Board of Trustees. The Managing Trustee shall have full administrative control over the working of the Trust in all the spheres of activities and functions and it shall be the duty and responsibility of the Managing Trustee to translate into action the objects and aspiration of the Trust from time to time. The Managing Trustee shall have:

- j) The authority to convene the meeting of the Trustees. The quorum of the meeting shall be 50% including the Managing Trustee.
- k) The custody of the properties and assets of the Trust on behalf of the Trust.
- 1) The authority to execute documents on behalf of the Trust and to affix the official seal of Trust for all purpose.

Powers of the Trustee:

Trustees of the Trust
